

In an effort to further streamline processes and improve efficiencies, Stein Mart is altering the formatting requirements of our GS1-128 carton labels. We encourage our vendors to transition to the new label format as soon as possible.

A detailed description of our “New Carton Label Guidelines” can be found under “Carton Labels” on the navigation bar. Please take the time to familiarize yourself with these guidelines. Stein Mart strongly suggests our vendors have their new labels tested by Bar Code Graphics prior to implementation. Contact information for Bar Code Graphics can also be found under “Carton Labels” on the navigation bar. Stein Mart cannot verify the accuracy of your label via email.

The illustrations below summarize the changes from the old format to the new.

The new format:

- Eliminates Field “C” - which contained a barcode representing the “Ship To Postal Zip Code.”
- Field “D” must list: Vendor Number, Department Number, and Carton Number. *If desired*, vendors may also use the right side of field D to list any carton content information needed for their purposes.
- Field “E” must contain a Bar Code representing the 9 digit PO number.
